



- 1. I, CS Ajit Sathe, proprietor of M/s A. Y. Sathe & Co., Practicing Company Secretary, Mumbai, have been appointed as Scrutinizer by:
- (a) The Board of Directors of Indoco Remedies Limited (CIN: L85190MH1947PLC005913) for the purpose of Scrutinizing the e-voting process under the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and
- (b) The Chairman of the Annual General Meeting (AGM) on poll under the provisions of Section 109 of the Companies Act, 2013 read with Rule 21 of the Companies (Management and Administration) Rules, 2014, on the resolutions contained in the notice to the 71st Annual General Meeting (AGM) of the Company, held on Tuesday, September 11, 2018, at MIG Cricket Club, MIG Colony, Bandra (East), Mumbal 400051 at 10,30 A.M. IST.
- 2. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and the rules relating to e-voting and poll on the resolutions contained in the Notice of the 71st Annual General Meeting (AGM) of the members of the company. My responsibility as a scrutinizer of the e-voting process and for the Poll at the AGM is restricted to make a Scrutinizer's report of the votes cast "in favour" or "against" the resolutions stated above, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited, the authorised agency engaged by the company to provide e-voting facility for e-voting and also the poll conducted through physical ballot forms at the AGM.

 - In accordance with the notice of 71st AGM dated 30th May, 2018, sent to the shareholders and the advertisement pursuant to Rule 20(5) of the Companies (Management and Administration) Rules, 2014, the e-voting period remained open from Tuesday, September 06, 2018 at 10:00 A.M. (IST) and ended on Monday, September 10, 2018 at 05:00 P.M. (IST).
 - ii. The members of the Company as on the "cut-off" date i.e. August 31, 2018, were entitled to vote on the resolutions (Item No. 1 to 5) as set out in the notice of 71st AGM of the company.
