Audit opinion

We have audited the accompanying financial statements of **Indoco Remedies Czech s.r.o.** (hereinafter also the „Company“) prepared with accordance with accounting principles generally accepted in the Czech Republic, which comprise the balance sheet as at 31. 03. 2022, the income statement for the year then ended 31. 03. 2022 and notes to the financial statements, including a summary of significant accounting policies and other explanatory information. For details of the Company, see information in the notes to the financial statements.

In our opinion, the financial statements give a true and fair view of the financial position of Indoco Remedies Czech s.r.o. as at 31. 03. 2022, and of its financial performance for the year then ended 31. 03. 2022 in accordance with accounting principles generally accepted in the Czech Republic.

Basis for opinion

We conducted our audit in accordance with the Act on Auditors and Auditing Standards of the Chamber of Auditors of the Czech Republic, which are International Standards on Auditing (ISA), as amended by the related application clauses. Our responsibilities under this law and regulation are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Act on Auditors and the Code of Ethics adopted by the Chamber of Auditors of the Czech Republic and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of matter

The company changed the accounting period from the calendar year 2021 to the financial year from 01. 04. 2021 to 31. 03. 2022. The reason of the change was the merger of the accounting period with the motherly company Indoco Remedies Limited.

We draw the attention of the Auditor's report recipient to the reported negative amount of equity, which is, however, covered by a liability to shareholders.

The Company reports data for the period from 01. 01. 2021 to 31. 03. 2021 in the part of previous period in the Income Statement for the period ended 31. 03. 2022.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.
