The company is primarily engaged in the manufacturing and marketing of formulations (finished dosage forms) and Active Pharmaceutical Ingredients (APIs). It has 11 manufacturing facilities in India, 7 for finished dosages and 4 for APIs, which is supported by a 1,00,000 sq. ft. state-of-the-art R&D Centre and a 150 Bed Clinical Research Organization (CRO). The manufacturing facilities are approved by various regulatory authorities including USFDA, UK-MHRA and TGA-Australia.

Indoco has a large basket of products backed by ANDAs / eCTD dossiers and Drug Master Files (DMFs). The company enjoys a good position in the domestic market with 45 products ranking amongst the top 5 in their respective therapeutic segments.
